


INTRODUCTION

CSB Associated Students (AS) was this year's recipient of the William J. Villa Award. The annual award was created in honor of the former UCSB Director of Admissions, William J. Villa. It is presented by the Vice Chancellor of Student Affairs and recognizes a university department that has demonstrated an extraordinary commitment to the general growth and development of students and quality of student life. All of us — students and staff — here at AS are honored by this campus-wide acknowledgement of the accomplishments of a truly extraordinary year.

AS is a student funded and governed organization dedicated to providing opportunities and services to UCSB students, our campus and the larger community. It's a place where students can become immediately engaged in whatever they're passionate about and become part of a family that values and actively supports that engagement and passion.

The truth of these words was sharply illuminated when the year began with an act of violence that has had a profound and lasting effect on UCSB students and on our community as a whole. Shortly after being sworn into office in May, AS's elected officials and the entire organization were called upon to respond to the murder of six UCSB students with 14 more left injured by a young man residing in Isla Vista who subsequently took his own life. AS engaged immediately to become an integral part of the university's response to this terrible tragedy. Working with campus administrators, faculty, and staff, students organized a candlelight vigil a day after that terrible night and then supported the campus administration in organizing the memorial that filled Harder Stadium. Ultimately, UCSB students showed the world that ours is a strong, resilient, and caring community. *Stay Strong!* is a new motto in this community.



This included beginning fall quarter with a free May 23rd remembrance concert in Storke Plaza headlined by Jack Johnson. The university also adopted new strategies for managing Halloween, including a Program Board produced concert that brought a significant number of students to the Events Center.



KCSB-FM 91.9

hroughout its over 50-year history KCSB-FM
has been a community resource and source of
programming not found on commercial radio, including music, public affairs, news, sports, and more.
It's the product of the dedication of over 100 student
and community programmers. Funded primarily by
students and an annual fund drive the station can be
heard over a 70 mile radius from Camarillo to Santa
Maria and offshore past the Channel Islands. Students
run the station with support from a small career staff.
Here's what they had to say about this year's accomplishments. Add to this countless hours of diverse
programming. Yeah, pretty amazing!

During the past 2014-2015 school year, KCSB-FM redoubled its commitment to Isla Vista and the greater local community by:



- Co-presenting our first-ever Hello World! free Isla Vista concert with the MultiCultural Center. Headlining act Chicano Batman went on to a big year of touring (and two later stints at the Santa Barbara Bowl). The world-music bill also featured Mexico68 Afrobeat Orchestra (also from Los Angeles) and the moody electronic-music trio Los Macuanos (from San Diego and Tijuana, Mexico).
- Hosting two popular open mics and an I.V. First Friday
 alternative cultural night to close out the year. We took
 our music programs out into the public, by airing one show live
 from Pardall Road during that First Friday event, and another
 during the Spring Warm Up outside the UCSB Thunderdome
 Events Center.
- Adding significantly to the year's slate of Come Together Isla Vista memorial events. We broadcast AS Program
 Board's Jack Johnson's live Storke Plaza concert; a KCSB led town-hall presentation on gun violence with Richard Martinez and Bob Weiss, parents of 2014's I.V. shooting victims; news and public-affairs coverage of the anniversary week; and announcements supporting student-community partnerships and activities.
- We demonstrated our commitment to innovation by introducing a two-week streaming archive of our programs to the KCSB website.
- We saw some significant improvements to our studio for live performances and panel discussions, "Studio A,"

including a long-overdue rewiring of all our studios. We also stabilized the power situation up at KCSB's Broadcast Peak transmitter site (at 4000 feat in the Santa Ynez Mountain range) and addressed temperature control issues there that threatened our precious equipment.

- We co-presented Brazilian indie artist Rodrigo Amarante's acclaimed poolside concert from Goleta's new hotel
 The Goodland, and broadcast his performance live along with UCSB flute sensation Azeem Ward and local reggae supergroup The Cameo Band.
- We organized a memorable master class with scientist and media hero Dr. Michio Kaku with the assistance of UCSB Arts & Lectures.
- We sponsored and aired other concerts and public lectures such as Gardens & Villa, The Coup, and Dr. Helen Caldicott.
- We hosted numerous live in-studio performances, including such major groups as Dengue Fever and Stone Foxes.

- We produced KCSB's first-ever "Live in Studio A" compilation CD which featured 19 acts performing a range of genres.
- Our film subcommittee helped document many of these accomplishments and boosted our web and social media presence.
- There is currently a growing interest in programming on KCSB, especially for our news and sports departments in fact, our news staff has grown several times over and have been producing nightly newscasts with renewed vigor and in volunteering behind the scenes on these aforementioned projects. The turnouts for our quarterly recruitments have been record-setting and are very encouraging for our future.
- Finally, KCSB received prominent and even unexpected print and online acknowledgment during recent months, including notice in the glossy monthly magazine covering our region's good life, Santa Barbara Magazine, in the daily newspaper, the Santa Barbara News-Press, and on BestColleges.com's list of "50 Best College Radio Stations."

My name is Madeline Kardos and I am one of the co-founders of the KCSB Film Committee. The other co-founder is the amazing Allyson Gonzalez, my co-worker and co-writer, producer, and director. The rest of the KCSB staff feared this partnership, as Ally and I did more laughing than working (according to them). We originally created the committee in order to film a video that we never actually made. This was our 'Legal Training Video' shown to all new KCSB DJs, which was in dire need of reconstruction. We intended to write and film a new version of this training video by the end of our term, but ended up creating original skits, personal interviews with our KCSB DJs, a wildly successful Instagram campaign, and live in-studio videos for bands such as Dom La Nena, Evolfo, and Rodrigo Amarante instead. You win some, you lose some.

Challenges? There were many, as we were all new to film-making. Finding cinematographers and editors that shared our vision and our alarming senses of humor was difficult. We finally found her. Christine Lee was my friend who I met day one of college, waiting in line to register our bikes in the FT

bike lot. Luckily, she was a film major as well and wanted to help KCSB for her last year of college. We also found fantastic interns from the Film & Media Productions office, who helped us immensely.

Finding equipment was also especially difficult, as KCSB did not have the budget for cameras, lighting, or sound. Instead, we branched out to other organizations such as the AS Media Center and the Film & Media Department, who really saved us.

The number one difficulty, however, was time. It takes time to figure out what you're even doing in the first place. It takes time to form a team. And it takes time to get in the groove and become good at what you're doing. We only had one year. As I was a graduating senior, time was of the essence. All I can say is that it went by way too quickly. There are many things I wish we could have done, such as that dang 'Legal Training Video,' however it's up to the next generation of KCSB Film Committee members to finish what I have started. Even though we were born out of chaos, the KCSB Film Committee is here to stay.

ISLA VISTA TENANTS' UNION

his year participants in the Isla Vista Tenants Union (IVTU) were compelled to take to the streets to protest the eviction of five households from the Abrego Apartments. The evictions were carried out by the new owners of the apartments, Majestic Asset Management, who renovated the apartments and

forced the existing tenants out. Working with the AS Legal Resource Center, IVTU fought to make sure the evicted tenants received the benefits they were entitled to by law. Although they were forced to relocate, the tenants eventually received compensation through an out-of-court settlement.




FAST FACT: PARDALL CENTER LOCK-IN FUNDING APPROVED

Passage of the "Maintaining AS's Isla Vista Presence" lock-in by students in this year's campus elections was a ringing endorsement of the impact the Pardall Center has had since its opening. This significant increase in the center's funding underlines the importance of having **a space for students administered by AS right in the center of Isla Vista**. The center serves both students and non-students by providing a safe space for meetings, study space, and computer access. The Pardall Center building also houses the AS Legal Resource Center and the IV Tenants Union.

CREATIVE MEDIA UNIT

Code. Its purpose is to integrate media services, including AS publicity, graphic design, videography and editing, media equipment check out, and media skills workshops into a single entity that can provide these services to AS and the campus community. The unit includes student videographers and graphic designers, and a team of students to work on projects like the *Care to Know* AS campaign that informs students about the wide range of services AS provides. This year Creative Media Unit also produced three *Senate Room* videos recapping what happened in the AS Senate. As a new entity, it is a work in progress and will no doubt develop over the years.



ISLA VISTA ENGAGEMENT AND SELF GOVERNANCE

the events of May 23, 2014 brought into sharp focus the need for deeper engagement by the university and Santa Barbara County in Isla Vista. They responded with concrete initiatives. AS is integral to these efforts, which include further development of the Pardall Center and, perhaps most importantly, revival of serious discussions aimed at some level of IV self-governance with student participation. The latter initiative received strong support from the AS External Vice President Local Affairs Cameron Schunk who worked with past AS President Jonathan Abboud to engage the Isla Vista community in this discussion.

With May 23, the Deltopia riot, general public order, and long-standing infrastructure and housing concerns very much at the forefront of people's thoughts, a series of town hall meetings were held.

Students, local homeowners, renters, and landlords attended the meetings. University and Santa Barbara County officials, including Supervisor Doreen Farr and State Representative Das Williams, also attended. The result was Assembly Bill 3 (AB3) introduced by Williams in the State Legislature to create a Community Services District in Isla Vista. Student involvement was critical to this process which sought to include all stakeholders.

The UCSB administration has also worked to increase the university's involvement in Isla Vista. A report prepared by the UCSB Foundation Trustees Advisory Committee outlined some of the steps that should be taken, including more uniform training of police officers serving in Isla Vista. Students also reached out to the County Sheriff's Department and the IV Foot Patrol to improve relations between students and law enforcement.

The university has increased the number of Campus Police Officers and the Santa Barbara County Supervisors voted to fund a Community Resources Deputy to become part of the Isla Vista Foot Patrol to serve as a liaison between law enforcement students and the local community.



OFFICE OF THE CONTROLLER ICLICKER RENTAL PROGRAM



at the end-of-year AS Awards Banquet. The award acknowledged the office's introduction of an iClicker program to campus. Students are required to use the iClickers in some of their classes, but for some they are cost prohibitive. They are now available for loan at the AS Cashiers and Ticket Office windows. Assistant Director for Business Services Ed Schatz worked with students to develop and implement the program. In addition to developing new ventures, the Controller's Office also assists in providing financial oversight over existing AS units.

TAKE BACK THE NIGHT



the United States was held in 1978. Take Back the Night UCSB traces its lineage to that original march against rape and all forms of sexual violence. It is a student-initiated committee dedicated to raising awareness about sexual violence through activism, advocacy, and survivor empowerment. Members are passionate about creating a culture of consent and ending sexual violence.

This year Take Back the Night (TBTN) hosted several events in the days leading up to Halloween and facilitated a safe space at the Pardall Center. Advocates from the Santa Barbara Rape

Crisis Center, UCSB Counseling & Psychological Services (CAPS), and UCSB Health and Wellness, as well as student volunteers were on site. TBTN hosted a social during winter quarter and an information booth at the annual V-Day event held in conjunction with a performance of Eve Essler's Vagina Monologues. As in past years TBTN hosted a rally during spring quarter that began on campus and proceeded through Isla Vista. The day culminated with a program in Anisq'Oyo' park that included survivors of sexual violence sharing their stories.

FAST FACT: HAPPY AND HEALTHY STUDENTS

The Commission on Student Wellbeing (COSWB) is all about keeping students healthy and happy with programs like **Fitness Tuesdays** that bring a variety of workouts to campus, including a Krav Maga self-defense series, and Free Yoga Thursdays. They're also all about helping students eat healthy. Mindful of the stresses of student life, they participated in the campus-wide **Stigma Free UCSB** campaign to address the stigma attached to seeking help with mental health issues.

QUEER PEOPLE OF COLOR CONFERENCE

ueer Commission supported the Queer People of Color Conference at UCSB this year. The conference offered attendees from across the UC and State College systems a wide range of workshops and other activities to both educate and provide safe spaces to network and share resources.

CONFERENCE SPEAKERS

The opening keynote speaker was Julio Salgado a Mexican-born artist and activist who uses his art to empower undocumented and queer people and

to advocate for the DREAM Act movement, which seeks to give children born in the United States to undocumented parents access to higher education and funding for that education. Other speakers and performers included, black/trans/ queer poet J Mase III, who also blogs for the Huffington Post, writer Mia McKenzie, and Grace Chang, Associate Professor in the UCSB Feminist Studies Department.






FAST FACT: '14-'15 RACIAL EQUALITY CONFERENCES

SCORE FACING RACE CONFERENCE




