hree-hundred and ninety-one days. That was the number of days I had left on my countdown the night I was elected AS President, April 25, 2013. I defined my presidency with a strong underlying sense of urgency, having been involved in Associated Students the previous three years. I knew too well that "a year is not enough." I got the countdown to remind myself every day that time was running out to fulfill my promise to make UC Santa Barbara a better place. A main motivation behind my candidacy, and that of my fellow officers, was my belief that the incredible potential the AS President has to influence change and move mountains for the betterment of students must be utilized to its maximum potential and breadth. This admittedly led to 80-hour work weeks from May 2013 to May 2014, but to put it simply, a lot got done.

As I was sworn into office, the general feeling was a sense of excitement and possibility. The destructive UC system-wide budget cuts and tuition increases that defined my first three years at UCSB, had seemingly come to a pause with the passage of **Prop 30**. UC Santa Barbara was soaring in development and reputation, and funds were beginning to trickle in for basic operations. Associated Students was also in aching need of internal reform after years of uncoordinated growth since the 2006 Students Initiative. As part of this reform, plans were in place to transform the Office of the External Vice President for Local Affairs into a more politically proactive office to improve Isla Vista systemically instead of with band-aid solutions.

We moved into the office on June 24 and on that day the pace of work accelerated ten-fold. My staff, the other executive officers, and I were in full swing in the office every day, working on the foundational bedrock that would reinforce our work the rest of the year. Seldom are all five executive officers and their top level staff in the

office for the entire summer, but our summer's productivity proves its worth. It is during this summer that plans for our major initiatives were mapped out and work on them begun. They included, Isla Vista Self-Governance, AS Restructure, Campaign for a New California State Master Plan, AS 2020 Strategic Plan, and implementation of the students-led Politics of the UC course, AS Endowment, Student Union Revitalization Fund (SURF), Campus-Wide Week of Welcome, I Love UCSB Campaign, the new AS Executive Fellowship, Student Initiated Democratic Education, and an endless list of other projects.

The summer included the most divisive event of the year, Janet Napolitano's appointment as UC President. This issue early on tested the purpose behind my position as AS President and how to balance the various stakeholders, and short- and long-term interests of the student body. Many students called on me and other student leaders to denounce Napolitano's appointment through a vote of No Confidence, citing her actions with regard to deportations as Secretary of Homeland Security and her lack of background in academia. I chose not to support the No Confidence movement and urged my colleagues at other UC campuses not to as well. This led to a very productive relationship between the Council of Student Body Presidents and the UC Office of the President (UCOP) compared to UCOP's relationship with the UC Student Association.

The External Vice President for Local Affairs Alex Choate and I attended two meetings of the UC Regents. We also attended the United States Student Association Congress, and UC Student Association Congress. It was at these events and our disappointment at the effectiveness of UCSA and USSA that we began to consider pulling out of USSA and significantly reducing our contribution to UCSA, since UCSB's contribution was nearly twice that of the next highest contributing campus. While

these organizations are important in the context of the greater student movement in support of public education, they at times lose their way or act against their own long-term interests, making it difficult to justifying over \$160,000 in student fees for membership costs, not including conference fees.

The fall kicked off with the first campus-wide **Week of Welcome**, a new partnership between Associated Students, the Residence Halls Association, and Student Affairs. This event aimed to bring together not just first year students, but the entire campus community to celebrate the start of the year and re-engage with academic and extracurricular activities.

During Week of Welcome, I had the honor of addressing the class of 2017 and transfers to the class of 2015 at the annual New Student Convocation. In my speech, I stressed the incredible ability of students to make an impact on our campus and society, the importance of meeting new people (I asked the students to take 10 seconds during the speech to meet someone new next to them), and celebrated the wonderful balance of activities present at UCSB and in Isla Vista.

The newly created AS Executive
Fellowship was the hallmark of fall
quarter. Prior internship opportunities were deemed as not engaging
enough for students, so my Deputy
Chief of Staff Nikka Kurland and I
set up this program, which for the
first time included educational and
professional development sessions
every week of fall quarter, homework
and tasks for fellows in training,
and, upon completion of the train-

ing, employment in one of the five AS Executive Offices. The program has been wildly successful, with graduates now running Associated Students at ever higher levels of effectiveness.

The original concepts for the AS restructure began in the summer and gathered momentum in fall. My colleagues and I brainstormed ideas on how to address specific structural ailments of AS such as long meetings, equality in appointments, uncoordinated growth, deficient financial oversight, overreliance on student fees, or lack of clear roles and functions. To find solutions, I researched the history and structure of the various student and city governments in California, including how AS used to function. Instead of addressing each structural issue individually, I decided the entire system needed to be overhauled to effectively address these issues.

After a failed first concept, I was at a standstill during winter break. I decided to list out every entity within Associated Students. In doing so, I noticed there was no clear way to group organizations by function — the word 'board' had no meaning, many of the committees were entirely different, etc. The foundation of the new structure was to organize AS according to functions and roles. This was the main reason acronyms like BCC and BCU were inherently incompatible with the restructure. It worked when a board was no different than a committee, but now there would be a clear difference and more entities than just Bs Cs and Us (boards, commissions, committees, and units).

The most radical change was the formation of the **AS units**. It is modeled on our former Business Services and ASUC Davis's structures. In the new structure, the AS President, IVP, Controller, and Executive Director focus on ensuring that each Unit is delivering its services fiscally efficiently and responsibly as operational or service arms of AS.

The Senate also received major upgrade with the implementation of a standing committee system based on AS UC Berkeley's to properly vet legislation. Administrative committees now provide the Senate with an extra hand in carrying out its constitutional duties, and the boards and commissions have been formalized as the policy and programmatic bodies that advise the Senate on major issues. Other technical reforms gave more oversight to the student officers and representatives directly elected by the student body.

Fall concluded with the launch of the campaign for a new master plan. The campaign attracted strong support and ignited renewed interest in the California Master Plan for Higher Education from many other student governments. It culminated in renewed partnerships between UC, CSU, and CCC at the January 2014 UC Regents meeting.

Winter quarter was certainly the busiest time of the year with multiple nationally-covered events on campus, including a meningitis outbreak, horrifying publicized sexual assaults, and a passionate campus-wide conversation about freedom of speech — the latter resulting from a Senate resolution calling for trigger warnings on syllabi and a physical confrontation between a professor and some abrasive pro-life activists on campus. It took the combined efforts of the executive officers and the AS Executive Director Dr. Marisela Márquez to steer the campus through these controversies. In particular, a press release regarding sexual assault led Chancellor Yang to demand survivor resources, increased lighting, and additional police officers specializing in response to sexual assault.

Teaching Political Science 106MM, Politics of the UC with

External Vice President for Local Affairs Alex Choate and Dr. Marisela Márquez was a highlight of the quarter, with a class of 20 students learning about the historical trends of higher education, how the UC system operates, and how to influence change with lawmakers. My hope is that this class continues to build a base of institutional knowledge so students can continue educating each other about the state of our education system and affect meaningful change.

The student-initiated 2020 Strategic Plan for the entire Association was another radical departure. It was inspired by the University of Sussex, and includes a system that will allow it to be maintained indefinitely. Long-term planning is essential to student organizations with a high turnover rate and I am proud that ASUCSB is one of the few student governments that learns from the past, acts in the present, and plans for the future.

**SURF**, an intitiative to expand the University and reform UCen governance, was another focus of my presidency. I wanted to continue former AS President Harrison Weber's effort to turn the UCen into a place that fully meets the students' needs and address the issue of space to house student organizations and services, including former foster youth, dance groups, and health and wellness areas. In a strong coalition effort, we managed to acquire the 3,500 signatures to place SURF on the ballot. However, our initiative was ultimately rejected by the voters

with only 46% of the vote.

For decades a paradigm has existed in which students have little to no say with regard to the University Center. To that end I advocated for allowing the AS President and GSA President to act as voting members of the UCen Governance Board along with a host of other internal reforms aimed at empowering the board and ensuring its responsiveness to student needs. This initiative unfortunately did not come to fruition, but we managed to pass some incremental reforms of the board.

Nothing could have prepared me, my fellow student leaders—espe-

cially my successor AS President Ali Guthy—and the greater community for the challenges of spring quarter during which our community was assaulted by an internationally **publicized riot** the evening of the annual Deltopia Festival and the subsequent murders on May 23, 2014 of six fellow Gauchos with many more injured by a lone gunman in Isla Vista. Isla Vista was rocked to its core by these brutal murders, but its true strength shone brightly as we came together to grieve, support each other, and set our community on a positive path. My only further comment on this tragedy will be to remember those who lost their lives that night: George Chen, Katherine Cooper, James Hong, Christopher Michaels-Martinez, David Wang, and Veronika Weiss.

Following the riot, Internal Vice President Kyley Scarlet and I urged the campus community to own up to allowing a culture of destructive behavior in our town and reconsider how we organize ourselves for celebrations in the future as opposed to traditionally laying blame on SBCC students and out-of-towners.

On a positive note, a high point of spring quarter was hosting the **Associated Students Reunion** during the All Gaucho Reunion. Current students enjoyed meeting AS alumni who had once held their positions and our alumni were able to reconnect and hear about what AS is doing in the present.

I released my budget shortly after the reunion and with it I became the first AS President since the 2006 Students' Initiative to put an end to the exponential increase of staff salaries every year in favor of funds toward funding historically fiscally-starved AS organizations and bolstering programs that support them. I further restructured the budget to begin looking at using revenues earmarked for some units to fund the activities of units that needed to be subsidized instead of raising student fees.

While there were many high profile tragic events in Isla Vista during the 2013-2014 year, they ultimately served as a spotlight on the blight our community has faced for decades. Two days before leaving

office (a week before May 23), myself and External VP for Local Affairs Alexander Moore and I, along with the other Executive Officers, brought statewide, local, university, and law enforcement officials together to jump start a new and fresh focus on addressing the needs of the Isla Vista community and emphasized the need for local self-governance. Success in this field extended and continues to extend beyond our term, but I will always be profoundly proud of the 2013-2014 Executive Officers for putting in place critical foundations across the campus and local area that are being built on through historic progress towards self-governance and increased funding for community development and policing in Isla Vista.

This cements my belief that students are and always will be at the forefront of progress. The power of students is bigger than any one person and I'm humbled to have had a role in continuing the work that came before me and making the work easier for those after me. To that end, I would like to thank my student mentors during my time as AS President: Harrison Weber, Chloe Stryker, Ahmed Mostafa, Kadeem Coad, Nathan Walter, Marjan Riazi, and Raul Martinez. Without them, I would've never dreamed of being AS President and they have my everlasting gratitude for that.



# Fast Fact

This year's most contentious issue for the AS Senate was a resolution to demand that the University of California divest from companies selling specific products — including military hardware — to Israel. Modeling their campaign on similar, and ultimately successful, campaigns to divest from companies supporting the apartheid regime in South Africa, supporters sought to challenge the Israeli government's policies toward Palestinians. Public comment representing both sides of the issue led to all-night Senate meetings. Ultimately, the resolution did not pass.





n May 23, 2014, six UCSB students - George Chen, 19; Cheng Yuan "James" Hong, 20; Weihan "David" Wang, 20; Katherine Cooper, 22; Christopher Michaels-Martinez, 20; and Veronika Weiss, 19—were murdered by a 20-year-old Isla Vista resident who ended his rampage by taking his own life. Fourteen other people were injured by gunshots or being rammed with his car. Immediately after the tragedy, Associated Students moved quickly to support and serve students in many capacities — offering comfort and emotional support individually and through student groups, referring students to available services on campus and in the community, holding spaces for students to come

together, providing tenants rights counseling, organizing memorial events and community forums, and interfacing with world media.

Although a number of campus and community groups were instrumental in organizing these efforts, it must be said that AS President Ali Guthy — who had just been sworn into office — deserves particular credit for owning her role as spokesperson and rallying point for students during those difficult days. By her example, she represented the caring and resilience that defines UCSB students — not just locally, but to the world.

As soon as the extent of the tragedy was known, efforts were made to acknowledge the losses and begin the healing process (as seen below).

Memorial Walk and Vigil at Storke Plaza

**Community Forum** 

On May 24, a day after the murders, the Memorial Walk and Vigil at Storke Plaza — organized by Associated Students, UCSB administration, and other concerned students — was attended by thousands of people. They filled all of Storke Plaza and overflowed into the surrounding area. The candlelight vigil in Storke Plaza was followed by a procession through Isla Vista. KCSB, university radio, broadcast the vigil live.

May 27 was declared a day of mourning and reflection. AS-led events on that day included a memorial service at Harder Stadium, where 20,000 people filled every seat in the stadium and half the field, and the 10,000 Ribbons for UCSB event. The following day, May 28, students organized a memorial paddle out and 1,000 **Cranes of Love**. Students also held a solidarity rally on June 5 at the Pardall Center in support of the Seattle Pacific University community after the shooting there.

AS organized four community forums, including a public safety **forum** sponsored by the AS Public Safety Commission at Isla Vista Theater on May 29, and a community forum on May 30.

The Pardall Center — at the center of Isla Vista and across the street from the IV Deli where Chris-

# Fast Fact

In the aftermath of the May 23 tragedy, United States Vice President Joe Biden addressed UCSB students, the families of the deceased, and the rest of the campus and IV communities in an almost-five-minute video that acknowledged the deep sadness the killings had brought and provided a message of hope for the graduating class of 2014. His message to students was a result of the work of '13-'14 Internal Vice President Kyley Scarlet.

killed — became a critical space for students and community members to come together in mourning and moving forward. AS student leaders and staff held open the space nonstop for the two weeks following the events, and sponsored a 24-hour café in collaboration with the IV Food Co-Op and the Coffee Collaborative from June 7-11.

Memorial candles, photographs, flowers, cards, and chalk messages filled the sidewalk in front of the building. From May 26 to June 10 the Memorial Wall at Pardall Center — a series of wood structures donated by Home Depot — provided a place for students and community members to write messages. On the second floor of the Pardall Center, the Isla Vista Tenants Union and the AS Legal Resource Center provided tenants rights and legal counsel to students desperate to leave their apartments in Isla Vista.

In addition to the events orga-

nized by Associated Students, AS served as a conduit for information about events that were being organized in Isla Vista and at UCSB by students and community members as part of the Isla Vista Week of Solidarity: Healing Together events from May 26 - June 15.

The media that descended on Isla Vista sought out student leaders for comments and the students developed a media response plan that allowed them to respond to the tragedy but also request that the media honor the need for privacy and community space for mourning.

Associated Students' leadership continues to support ongoing collaboration and participation in community-based initiatives and projects aimed at acknowledging the fact that everyone reacts to traumatic events differently, that healing takes time, and that sustained efforts must be made to strengthen our campus and Isla Vista communities.







he Pardall Center officially opened its doors this year to better serve students and the Isla Vista community. It's located in the center of IV on the ground floor of the building that has housed the AS Isla Vista Tenants Union and the Legal Resource Center for many years. In just a short time, it has become a community hub providing a safe space for meetings, quiet study, computer access, and a staging area for IV-community events like the Pardall Carnival produced at the beginning of each year by the Isla Vista Community Relations Committee (IVCRC) and the Community Affairs Board (CAB).

The Pardall Center is the product of students identifying a community need and working to address it, in

this case by having an AS-presence right in Isla Vista. Other activities hosted by the center include study jams during midterms and finals, annual AS budget hearings, and outreach to the non-student community including families. This outreach seeks feedback from the community in the form of a questionnaire available online in both English and Spanish. Community members can

also access legal resources vetted by the Legal Resource Center on the center's computers.

Students working through AS are committed to serving the entire Isla Vista community. In fact, during the 2013/14 fiscal year, AS spent over \$100,000 to open and maintain the Pardall Center. In all, AS committed over \$500,000 to Isla Vista and countless volunteer hours!

# Fast Fact

The Isla Vista Community Relations Committee (IVCRC) began the year's festivities with the annual Pardall Carnival. At the other end of the year, IVCRC, Community Affairs Board (CAB), and Program Board presented the annual Chilla Vista festival. This year's festival was held in Perfect Park in Isla Vista and was an ideal compliment to the Pardall Carnival. The festival featured a host of great local bands, inclu ing headliner FMYLYBND, That's What She Said, Alright Alright, The Olés, and The Fire Department. A variety of organizations provided information, activities, and even free food from the IV Food Co-Op. At the end of the day, a good time was had by all and Chilla Vista was once again a great showcase for the chill vibe of a typical AS student-produced event.





his year saw the revival of the AS Media Center and the beginning of its reinvention as the go to stop for students wanting to check out camera equipment and needing to do post-production work on their media projects.

The Media Center is the only place on campus where UCSB students can check out equipment without restrictions. All they need is their Access card. The service proved to be very popular with students from a variety of disciplines across campus and will continue to grow as AS acquires more equipment. Currently, the center has a line of Canon DSLRs

with video capabilities and professional quality tripods. It also has 4 iMacs with Adobe Creative Suite and Final Cut Pro software installed.

In addition to equipment check

out, the center offers skill-building workshops ranging from photography to video to graphic design. Although attendance at the workshops has been a bit disappointing, it will surely grow as more and more students and staff hear about these opportunities. This year, the workshops were taught by AS staff, but the center is actively seeking teachers from beyond AS including students.


The center also serves as a meeting space for AS and other campus

groups and a quiet study space. The Bottom Line, Student Initiated Recruitment and Retention Committee (SIRRC), Food Bank, KCSB, and America Reads are among the groups that utilize the center on a regular basis. Community Financial Fund (CFF) workshops are also held there. Several AS groups have hosted midterm and finals study jams at the center.

Over the course of the year, the AS Media Center has blossomed and is well on its way to fulfilling its potential as a dynamic creative space for UCSB students from across campus.

he AS Living History Project:
A Collective History of Student
Engagement at UC Santa Barbara (scalar.usc.edu/works/livinghistoryproject/) is the work of AS
Living History Project Coordinator
Mahader Tesfai. It is a remarkable
online document that complements
the printed AS annual reports and
the online AS Flashback reports.

The project was begun in 2011 with support from AS Executive Director Marisela Márquez. It is a collection of stories and remembrances — oral history interviews, photographs, radio archives, and other media sources — chronicling the political impact students have had on our campus and beyond. It

highlights the role student activism at UCSB has played and continues to play in shaping the campus and surrounding communities. Current chapters include, "Student Response to War", "Women's Organizing," "Black Student Organizing," "Santa Barbara Environmental Organizing," and many more.

One of the main ideas guiding the project has been the desire to build a collaborative history to help provide organizational continuity for AS. Knowledge of what has come before increases students' effectiveness in their ongoing efforts to promote meaningful change on our campus. With this in mind, the project also seeks to build and

strengthen ties between Associated Students, the general student body, UCSB administration and faculty, and the Santa Barbara community at large. Mahader has already reached out to the UCSB Public History Program and created a number of informational brochures highlighting different aspects of the information he has gathered.

As its title suggests, the *Living History Project* is an ongoing and living historical document. There are many stories that need to be told that are currently not in the project's pages. If there is anything that you feel would make this document more complete please submit ideas and/or content.

# Fast Fact

Queer Commission provided significant funding to bring author Janet Mock to the Multicultural Center during winter quarter for a reading, Q&A, and book signing. The event was hosted by the UCSB Resource Center For Sexual & Gender Diversity. After publiclyproclaiming her identity as a transgender woman in a 2011 profile in Marie Claire magazine, Janet focused her efforts on speaking about the struggles, triumphs and portrayals of girls and women like herself. In 2012, she launched #GirlsLikeUs, a movement that encourages trans women to live visibly. She currently writes and speaks about her experience of living at the intersections of identities.







extbook prices have been escalating for many years to the point where many students simply can't afford them. The Student Initiated Recruitment and Retention Committee (SIRRC) responded to this problem by launching the Associated Students Book Bank. The AS Book Bank is a student-run service that is available to all UCSB students, both undergraduate and graduate. All books donated to the bank are for loan and not for resale. Students can check out books for a certain amount of time.

To increase its holdings, the book bank collects books at several campus locations throughout the academic year. The books are then catalogued and can be checked out at the AS Annex.

his year the AS Legal Code was substantially rewritten resulting in organizational changes that will have lasting effects. These efforts were coupled with the development of a 5-year Student Strategic Plan to chart the organization's future. The hope is to make AS more responsive both internally and in terms of serving UCSB students. The new initiatives have included vesting more authority in the Senate, consolidating various BCCs (boards, commissions, and committees), and the creation of several more student positions within AS. A core feature of the restructuring is the creation of Units within AS that organize AS according to functional affinities.

Many of these developments are an acknowledgement of the continued growth and increasing complexity of AS as students identify community needs and provide more services. It also reflects the fact that, because of funding constraints in other areas of campus, AS has over the past several years been called upon to provide services that are critical to students, including establishing a more robust presence in Isla Vista.

As has been the case throughout its history, the challenge for students working through AS is to sustain initiatives from year to year as new students fill executive, legislative, and AS group positions, and seek to make their own mark. It's truly a balancing act supported by the AS career staff, which provides much needed continuity for the organization and has developed its own strategic plans.

The hope is that the reworking of the Legal Code and the development of long range student and staff strategic plans will provide structures to help guide AS through multi-year projects and in general work more effectively.

# Fast Fact

The Environmental Affairs Board (EAB) worked to raise awareness across campus about the drought gripping California. Efforts included creating a fact sheet about where our water comes from, what the current levels are, and easy tips to help students cut their water use. EAB also collaborated with Housing and Residential Services to facilitate a residence hall—wide water-saving competition. EAB tabled to let residents know about the event, and created visuals to post around residence halls with information about how to conserve.




